
Decarbonization Plan for Orange County Group

The project included 4 major steps. baseline assessment of the current scenario, identification of gaps and improvement areas aligned with the Net Zero 2030 vision, and the presentation of a clear roadmap to help Orange County achieve its decarbonization goals.

Baseline assessment:


- Mapping the current energy, material, water, and waste emissions across all projects.
- Conducting a GHG inventory of the scope 1,2, and 3 emissions in line with the GHG protocol and ISO 14064.

Target setting:

- Identify gaps and emission hotspots to prioritize key areas.
- Define short, medium and long term targets for carbon emission reduction.
